Official Rules for the Peloton Sweepstakes

No Purchase Necessary. A Purchase Will Not Increase Your Chances Of Winning.

- 1. Eligibility: The Sweepstakes is open only to legal residents of the United States who are at least eighteen (18) years old. Employees of Pendo.io, Inc. - 4. **Drawing:** On or about September 2, 2021, Sponsor will select one (1) potential winner in a random drawing of all entries received during the Entry Period. The odds of being selected depend on the number of entries received. The potential winner will be contacted via email and will be required to respond within 72 hours days. If the potential winner doesn't respond within this time, Sponsor may select an alternate potential winner in his/her place in a random drawing of all remaining entries.
